New GAAMPS draft would allow large livestock facilities almost anywhere

Township officials are urged to tell a state commission not to eliminate zoning considerations from a section of the Generally Accepted Agricultural Management Practices (GAAMPs). The Michigan Agricultural and Rural Development (MDARD) Commission are accepting



public comments until Monday, Oct. 29 and could consider as early as Nov. 7 a proposed draft of the <u>Site Selection and Odor Control for New</u> <u>and Expanding Livestock Facilities GAAMPs</u>. This draft would eliminate local land uses and plans from site selection criteria, meaning **if this draft becomes final, large livestock facilities could locate almost anywhere, with no consideration of local zoning**. MTA opposes this dramatic policy shift and is asking township officials to contact commission members as soon as possible to share your objection to this proposed draft. The commission is accepting public comments on the draft until 5 p.m. Monday, Oct. 29. Comments must either be emailed to MDA-Right-To-Farm@michigan.gov, or the public may provide input at a meeting at 9 a.m. Monday, Oct. 29, in the Gordon Guyer Conference Room in the William C. Ballot proposals up for a vote

Next month, voters will be asked to consider three ballot proposals when they head to the polls. Proposal 18-1 would legalize recreational marijuana, and also allow townships to ban or limit recreational marijuana facilities from their jurisdictions by passing an ordinance. Under Proposal 18-2, Michigan's congressional, and state House and Senate district boundaries would be determined by a new 13-member commission made up of selected applicants to represent Republicans, Democrats and political independents. Proposal 18-3 would provide voters with new voting rights, including straight-party voting, in-person registration



extended to Election Day and no-reason absentee voting. MTA did not take a position on these proposals, but will continue to inform members of the impact on townships. MTA concerned about logging truck bill



Logging trucks could travel county roads without weight, height and width restrictions under a bill awaiting action on the Senate floor. <u>SB 396</u>, sponsored by Sen. Tom Casperson (R-Wells Twp.), includes language allowing county road commissions to require a \$2,000 bond per mile traveled by unrestricted forestry vehicles; however, the bill does not specify consequences for failure to pay the bond, and in many cases, the amount would not be sufficient to address damage. State and local

jurisdictions would be required to post signs on roads subject to seasonal restrictions at least 48 hours before those restrictions went into effect. Jurisdictional authorities could also issue a special permit authorizing the highway operation of a vehicle delivering new or used machinery as part of a sale, with the ability to charge a special permit fee up to \$25. SB 396 would also allow the operation of a pneumatic tired forestry vehicle or a forestry harvest vehicle for a distance of up to 20 miles--potentially causing more damage to county roads. Contrary to what some townships may have been told, MTA has been involved, testifying in committee, participating in workgroup meetings and raising concerns about the impact to local roads and the costs for townships. We continue to be engaged in discussions on amendments and will keep members updated.
