This is the third and final listening tour stop designed to gather input from local officials and residents across Michigan on the current state of Michigan's infrastructure, the infrastructure system citizens envision, and how the state can work with residents to close the gap between the two. The input gathered will help shape the commission's final report and recommendations, due to the governor by Nov. 30, 2016. Registration is capped at 150 people, so RSVP today. Assessor certification requirements to change

The State Tax Commission recently approved changes to assessor certification renewals that could result in additional costs to townships. Certification renewal credits for municipal assessors will increase starting in 2017, and this fall, assessors will be required to complete 20 hours of continuing education in the next year in order to recertify. The hours must be finished between Nov. 1, 2016, and Oct. 31, 2017, and just four of the 20 hours can be completed online. #### Comment now on proposed GAAMPs changes

Township officials have the chance to give their input on next year's drafts of Michigan's Generally Accepted Agricultural and Management Practices (GAAMPs). Changes, which are available online, have been proposed to several GAAMPs, including manure management and utilization, care of farm animals, and site selection and odor control for new and expanding livestock facilities. A public input meeting will take place at 9 a.m. Thursday, Sept. 8, in the Lake Superior Conference Room at the State of Michigan Library and Historical Center, 702 W. Kalamazoo St., Lansing. Written comments may also be postmarked by Sept. 8 and submitted to the Michigan Department of Agriculture and Rural Development's Environmental Stewardship Division, P.O.
