LEGISLATIVE UPDATE

Continuing resolution prevents federal government shutdown

A \$288.3 billion continuing resolution (CR) signed last week prevented the federal government from shutting down. The resolution, HR 5325, was signed by President Barack Obama to extend funding for the federal government from Oct. 1 until Friday, Dec. 9, 2016. Additionally, the continuing resolution contains \$82.5 billion for Veterans Affairs and military



construction activities of the Pentagon. It also includes \$1.1 billion to fight the Zika virus and \$500 million in emergency flood relief, which is offset by \$400 million in ending contracts. While the CR does not include funding for the Flint water crisis, Speaker of the House Paul Ryan and House Minority Leader Nancy Pelosi reached an agreement that the issue would be addressed in the lame duck session.

Bill would delay federal overtime rule

A rule that would greatly increase the number of workers eligible for overtime would be put on hold for an extra six months under a bill recently passed by the U.S. House. Earlier this year, the U.S. Department of Labor issued a final rule on overtime regulations raising the salary threshold for overtime eligibility from \$23,660 to \$47,476 a year. The rule is supposed to be effective on Dec. 1, 2016. However, the House voted 246-177 to pass HR 6094, which would delay the rule from taking effect until June 1, 2017. President Obama has made it clear he will veto this bill if it clears the Senate and makes its way to his desk.

Mail absentee ballots for the military

The U.S. Postal Service recommends these mailing dates to ensure absentee ballots are delivered in time. Some APO/FPO locations require 14 mailing days or more, including Ethiopia, with the recommended mailing date of Oct. 9, and Atlantic/Pacific fleets, with a recommended mailing date of Oct. 10.

Dam management grants available

Townships can now apply for the Michigan Department of Natural Resources (DNR) <u>Dam Management Grant Program</u>, which aims to address Michigan's failing dam infrastructure through funding dam removals and critical repair and maintenance. The program provides funding and technical assistance for projects that will enhance aquatic resources and fishing opportunities while also reducing infrastructure costs and improving public safety.
